The Department of Education (DepEd) Region VII - Division of City of Bogo, through the BASIC EDUCATIONAL FACILITIES FUND (BEFF), intends to apply the sum of SIX MILLION NINE HUNDRED SEVENTEEN THOUSAND FIVE HUNDRED NINETY FIVE PESOS AND 61/100 ONLY (6, 917, 595.61), being the Approved Budget for the Contract (ABC), to eligible payments under the contract for the **CY 2018 RESTORATION OF GABALDON BUILDINGS** under the **BASIC EDUCATIONAL FACILITIES FUND (BEFF)**. Bids received that exceed the ABC per lot shall be rejected at bid opening.

The DepEd Division of City of Bogo through its Bids and Awards Committee (BAC), now invites bids for the above-mentioned works. Prospective bidders must have an experience of having completed at least **one (1) contract that is similar to the contract to be bid**, and whose value, adjusted to current prices using the NSO consumer price indices, must be at least fifty percent (50%) of the ABC to be bid. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instructions to Bidders. Bids received that exceed the ABC per lot shall be rejected at bid opening. Bidder must bid for all items in a lot, otherwise, the bid shall be rejected. Bidder may bid for one, more than one or all of the lots. Evaluation and award shall be made on a per lot basis.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships/partnerships, or organizations with at least seventy five percent (75%) interests or outstanding capital stocks belonging to citizens of the Philippines.

Interested bidders are required to login at the PhilGEPS website, otherwise they will be disqualified.

A complete set of Bidding Documents may be inspected or purchased at the DepEd Division of City of Bogo BAC Secretariat, located at DepEd Division Office, Buac, Cayang, Bogo City upon accomplishing a bidder's information sheet and payment in cash of a non-refundable fee by interested bidders in the amount of **TEN THOUSAND Pesos (Php 10,000.00)** to the DepEd Division Cashier. Only bidders who purchased the Bidding Documents will be allowed to submit bids (ITB 6.8).

It may be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS), [www.philgeps.net](http://www.philgeps.net), provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.

Bids will be opened in the presence of the bidders or representatives who choose to attend the opening of bids at the address stated herein. Late bids shall not be accepted.

The DepEd Division of City of Bogo reserves the right to reject any and all bids, declare a failure of bidding, not award the contract(s), or annul the bidding process without thereby incurring any liability to the affected bidder or bidders.
